NARRATIVE

On Wednesday 9/7/22 at approximately 1607 Hours, I responded to a call for a domestic dispute at 535 Buckhalter Rd. Upon my arrival, I made contact with the complainant (identified as Leilani Simon).

Leilani said her and her mother had an altercation regarding some clothes that were in the wash. Leilani said she removed her clothes so that her mother could use the washer. Leilani said they had a disagreement verbally about "how things were" and she said her mother got in her face and shoved her. Leilani said she hit a wall and felt that her elbow was red from the wall. Leilani said her two kids were around and said she called to put a stop to the issues between her and her mom as she said she did not want her kids around that.

Leilani's elbow was red, however there was no signs of bruising.

I made contact with the mother (identified as Billie Howell). Ms. Howell said she was having issues with her daughter as she said she wanted to use her washer and it was in use. Ms. Howell said she was frustrated as she takes care of the house hold and pays all of the bills. Ms. Howell said her daughter lives there, two kids, and the daughter's boyfriend. Ms. Howell said she got in an argument with her daughter (Leilani) and said after her daughter screamed at the top of her lungs in her face, she shoved her.

Leilani said she was on probation and did not want the conflict to escalate and said that was why she called. Leilani said she did not want her mother to face charges. Leilani was advised she could go to the court house and attempt to get warrants taken out if she wished. Leilani said she understood.

Ms. Howell's son came to pick her up to remove her from the situation. Ms. Howell agreed to separate from the situation for some time to avoid conflict. Ms. Howell said she may have to evict them. Ms. Howell's son advised that his mother was tired as he said the daughter has a history of stealing from the mother and buying drugs with that money and says the problem goes back very far. Ms. Howell left the scene with her son for at least a few days.
